Most people think of mediation as a tool to settle disagreements outside of court, but mediation can be used in another way.

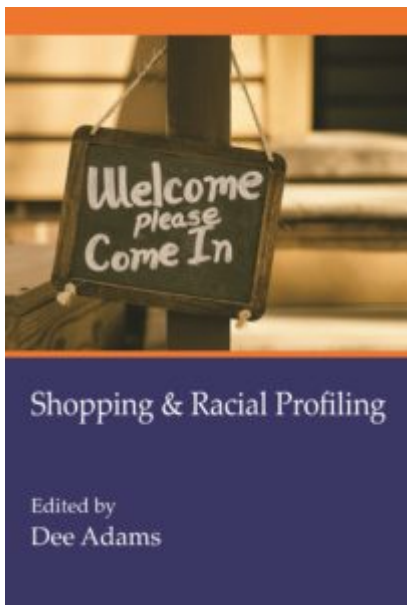
Business disputes are often caused by lack of clear communication between the parties about their expectations.

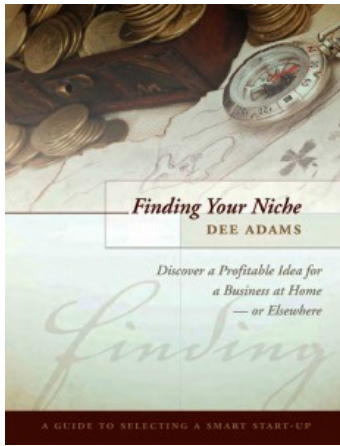
